The total concentration of heavy metals: cadmium, mercury, lead and hexavalent chromium in the plastic raw materials is less than 100 ppm. **PHTHALATES**

No phthalates, including di-(2-ethylhexyl) phthalate (DEHP), dibutyl phthalate (DBP), benzyl butyl phthalate (BBP), diisononyl phthalate (DINP), diisodecyl phthalate (DIDP), and di-n-octyl phthalate (DnOP), are intentionally added to these products and they do not contain Phthalates as listed in EC Regulation 10/2011 dated 14 Jan 2011.
