

We hereby declare that the plastic raw material such as HDPE other additives and colour masterbatches used in the production of Euro Containers comply with the relevant directives, and Meets the requirement stipulated in standard IS: 10146 on "Specification for Polyethylene for safe use in contact with foodstuff, pharmaceutical, and drinking water". It also conforms to the positive list of constituents as prescribed in IS: 10141. The grade and the additives incorporated in it also comply with the FDA:CFR Title 21,177,1520, Olefin polymers.

There is no intentional addition of Cadmium, Chromium, Lead, Mercury used in the production of euro packaging material. ### **PHTHALATES**

No phthalates, including di-(2-ethylhexyl) phthalate (DEHP), dibutyl phthalate (DBP), benzyl butyl phthalate (BBP), diisononyl phthalate (DINP), diisodecyl phthalate (DIDP), and di-n-octyl phthalate (DnOP), are intentionally added to these products and they do not contain Phthalates as listed in EC Regulation 10/2011 dated 14 Jan 2011.
